### **KEY INFORMANTS NEEDS ASSESSMENT**

Back in the September meeting of the Coalition, we began to look at the concerns of the Health and Human Service Providers by the means of a Key Informant Needs Assessment. This was further clarified during the October meeting of the Coalition through a handout that participants filled out. The assessment form listed (1) the critical issues for residents of Northern Berkshire and (2) the most pressing issues in the Health and Human Service Network. Participants voted for the five issues in each category they felt to be most important. After long and careful tabulations, the following are the results.

Most critical issues for residents in Northern Berkshire:

1. Employment
2. Low cost housing
3. Stabilization and regrowth of our economic base
4. Health issues
5. Youth Programs / Substance Abuse Services (tie)

Most pressing issues in the Health and Human Service Network:

1. Families in crisis
2. Teen Pregnancy
3. Coordinate efforts among agencies to work together
4. Employment
5. Self esteem of Northern Berkshire residents

What are the implications of this needs assessment? Clearly it points to directions that the Coalition has been heading in the past months (housing, health, COORDINATION OF EFFORTS, teen pregnancy...). Yet it also looks at issues that are concerns of the area and need closer examination (youth programs, families in crisis, self esteem.....). What do you think? Do these results reflect your concerns regarding the social welfare of the Northern Berkshireites? Comment to Al Bashevkin. More to come.

## REPORT ON COALITION MEETING OF OCTOBER 10, 1986

Once again, we had a significant turnout for the October Coalition meeting at the American Legion Hall in North Adams. Over forty people were in attendance, representing a broad spectrum of interested participants. Senator Peter Webber, instrumental in the forming of the Coalition, assisted with his perspective as a state senator. The agenda of the meeting included participation in a Key Informants Needs Assessment (see tabulations elsewhere in newsletter) and reports from the various task forces. The energy of the meeting was so high we forgot to break for coffee, (we'll do better next time). A summary of the task force reports:

### HOUSING :

The Housing Task force report was delivered by Therese Louison. The Housing Task Force is looking at the problem of an insufficient amount of suitable, affordable, housing that meets basic health code standards as its major concern. Emergency shelter and housing for teenagers are also concerns that the task force is looking at. The task force is inviting representatives of all affected groups to participate in this dialogue and has included the housing code inspector from North Adams (John Taft) and Nick Peck from the Department of Social Welfare. The task force has also endorsed the Massachusetts Right to Housing Project. The Project is assembling petitions (65,000 signatures statewide) to ask the commonwealth to put as a referendum vote the right to non transient housing for all in our state constitution.

### HEALTH CARE:

The Health Care task force report was delivered by Thorman Hulse. The task force is focusing initial efforts towards the major concern of high numbers of our population without health insurance. We have had a number of meetings with the Department of Public Health, most recently with Tom Salmon and Sally Fogarty. Dr Bailus Walker, commissioner of the Department Health, has expressed strong concern about the lack of access to health care for much of our population. Tom and Sally have presented us with their picture of the State's predicament regarding new programs, yet they were able to leave us with some hope about Maternal Infant Child grants that will be appearing shortly and that our region has strong needs for. Health Care Task Force is also working on how to present those free care programs already available so the public will take full advantage of them. Len Radin has assisted the task force with information on free dental programs available in the State.

## INFORMATION OUTREACH

In a most thorough presentation, Ken Swiatek presented us with the work of this task force. Information outreach is trying to better disseminate (not insemminate) the information about available services to the public. They urge stronger coverage from the Press (can't do any worse), support for the resource notebook that Helpline is assembling, inserts to the newspapers about available resources in the area, Coalition mailing lists available to all (they are - contact Al), assembling a speaker's bureau, and consideration of different sites for the Coalition. Lastly, the outreach task force took it upon itself to make this Coalition stuff more fun by augmenting the tedium of Social Change with Coalition Socials. More to come on the latter and other ideas later.

## SUBSTANCE ABUSE

In what was the most engaging report, Sharon Vargo reported to the Coalition on the work of the Substance Abuse Task Force. There is a planned Request for Proposals (RFP) from the Department of Public Health that two area agencies are interested in. Substance Abuse services will change in the area as the result of this RFP. Discussion of substance abuse services centered on what will be best for the Northern Berkshire area. Service gaps in our area include teenagers, adult children of alcoholics, the college population, the unemployed /underemployed. More segments of the service population need to be recruited to examine the need for substance abuse services in our area so we can present a thorough application to DPH. All parties agree that more substance abuse services in North County are needed that are well integrated with existing institutions.
